Mitek Systems, Inc. (the "Company") is unable to file its Quarterly Report on Form 10-Q for its fiscal quarter ended June 30, 2023 (the "Q3 Form 10-Q") within the prescribed time period without unreasonable effort or expense for the reason described below.

As disclosed in the Company's Current Report on Form 8-K filed on May 27, 2022, the Company received formal notice of the resignation of its previous independent registered public accounting firm, and as disclosed in the Form 8-K filed on July 18, 2022, engaged a new independent registered public accounting firm to act as the Company's registered public accounting firm. As a result of the Company's transition to a new independent registered public accounting firm and the delays related to the filing of the Company's Quarterly Report on Form 10-Q for the period ended June 30, 2022, filed on October 28, 2022 and the Amendment No. 1 to the Company's Quarterly Report on Form 10-Q for the period ended March 31, 2022, filed on October 28, 2022. The Company needed additional time to complete its procedures related to its Annual Report on Form 10-K for its fiscal year ended September 30, 2022, filed on July 31, 2023 (the "Form 10-K"), including compiling and analyzing supporting documentation in various areas that is necessary for the Company's independent registered public accounting firm to complete its audit procedures relating to the Form 10-K. As a result, the Company has not yet filed its Quarterly Report on Form 10-Q for the period ended December 31, 2022 (the "Q1 Form 10-Q") or its Quarterly Report on Form 10-Q for the period ended March 31, 2023 (the "Q2 Form 10-Q") and cannot file the Q3 Form 10-Q until the Q1 Form 10-Q and Q2 Form 10-Q are filed. The Company expects to file the Q3 Form 10-Q as soon as practicable following the filing of the Q1 Form 10-Q and the Q2 Form 10-Q.
