

Mitek First to Offer Omnichannel ID Verification Experience

Seamless desktop-to-mobile ID document authentication and new device ID capabilities added to Mobile Verify™

The new features strengthen Mitek's industry leading identity verification platform, which mitigates the risk of application fraud and improves customer acquisition in the mobile channel.

At the event, Mitek will demonstrate the first omnichannel enrollment process that can begin with a desktop application and be completed on a mobile device. After starting the process on a desktop computer, the applicant is texted a link to activate the camera to capture a photo of their license to be verified in the online session. The company will also demonstrate a new capability that seamlessly combines a driver license verification with a cross check of device ownership.

"Now in addition to mobile account opening, Mitek enables safe and secure customer acquisition using a desktop computer, providing financial institutions with a truly omnichannel ID document verification experience," said Sarah Clark, general manager, Identity Business Unit, Mitek. "This omnichannel process, coupled with our new device ownership capability, makes Mitek's Mobile Verify the most powerful identity verification platform on the market today."

Mobile Verify has the potential to replace the Knowledge Based Authentication (KBA) methods that are currently used to verify a user's identity. According to <u>Gartner</u>, difficult to answer KBA questions do not stop fraudsters and only create hurdles for customers. An average of 15 to 30 percent of customers fail identity proofing challenges based on personally identifiable information (PII data) and life history questions, while up to 60 percent of criminals pass. Mobile Verify allows organizations to meet regulatory requirements while also optimizing the mobile channel for customer acquisition and secure transactions.

Mitek will present its latest mobile offering during Demo Session 4 on Tuesday, May 10 between 2:50 and 4:10 p.m. PT.
